Entry Declaration

I/we, the undersigned apply to enter the event described above and in consideration thereof:-

- 1 I/we hereby declare that I/we have had the opportunity to read, and that I/we understand the National Sporting Code of the SACU and ACU, the SACU and ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- 2 I/we further declare that I am/we are physically and mentally fit to take part in the event and I am/we are competent to do so.
- 3 I/we confirm that I/we understand the nature and type of event I/we are entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of organisers or officials.
- 4 I/we confirm that the machine(s) as described overleaf which I/we compete on shall be suitable and proper for the purpose.
- 5 I/we confirm that if any part of the event takes place on a public highway, the machines described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that it/they will comply with the regulations in respect thereof.
