### **DISCLAIMER**

In consideration of being permitted to participate in this event, I declare as follows:-

That I am fit and not suffering from any physical or mental disability which would impair my safe participation in the meeting and I undertake to inform the organisers immediately should any change in my condition occur which I have reason to or ought to have reason to believe would affect my ability to continue to participate in this competition.
3. I have been given the opportunity of inspecting the course / track / circuit and its facilities and hereby declare myself satisfied with the course / track / circuit and its facilities. If during the course of the competition circumstances change, it will be my decision as to continuance or otherwise of competing. 5. I am satisfied that the venue is safe for me to compete upon and that should I, at any time, have any doubts as to their safety, I am entitled to decline to compete thereafter and that I may inspect each circuit prior to competing thereupon.
6. As a participant I may be exposed to the risk inherent in motor sport and that I am prepared to take such risks.
7. I further agree that I shall not seek to claim against the SACU, the organisers, their officials, the landowner, the promoter or other bodies or individuals connected with the event in respect of any damage to my property howsoever caused and whether by the negligence or breach of statutory duty of the said bodies or persons.
8. **Acknowledgement of the risks of motorsport:** I understand that by taking part in this event, I am exposed to a risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event of negligence on the part of the ACU/SACU, the promoter, the organising club, the landowner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.
