**1. OFFICE VACANCY**

It has been agreed by the SACU Directors and also by Locktons Insurers that I.O.P.D. Licences will be acceptable at SACU Off Road Events (NOT Road Race) on the understanding that the riders will NOT be covered under the Personal Accident Scheme and that Club Secretaries should have 2 separate signing on sheets stating this to the I.O.P.D. Licence holders. They can of course buy a One Event Licence and they would then be covered the same as SACU Licence holders. I have enclosed a copy of the revised Public Liability Insurance, which states this on it. If anyone has any questions on this matter, please do not hesitate to contact me at the office.
