### Supplementary Regulations

1. No "Fun bikes" or non-competitive bikes will be allowed on the ground.
2. "NON – STOP" method of marking will be used.
3. Registration Card MUST be shown when signing on at the start.
4. Method of deciding ties: - most cleans, if still tied – most 1s, most 2s etc.
5. Sections will be closed by back marker, time advised at riders meeting.
6. All competitors must have a cut out device rigidly connected to the rider by lanyard.
7. Parents or guardians of youth(s) signed on must not leave the ground.
8. Protests must be received in writing accompanied by a £50 protest fee.
9. Riders must keep to the flagged route.
10. Riders, minders and observers must sign on and off at the start and finish of trial.
11. **Dunfermline club members must supply an observer.**
12. Closing date for entries, Friday 6<sup>th</sup> July 2018.
13. No late entries.
