To be held under the National Sporting Code rules of the SACU, the Standing Regulations for trials, these supplementary regulations and any final instructions which may be issued up until the start of the trial. The method of marking for this trial will be TSR22B (no stop).

SUPPLEMENTARY REGULATIONS. (please read carefully)

1. No “Fun bikes” or non-competitive bikes will be allowed on the ground.
2. “NON-STOP” method of marking will be used.
3. Trials Registration Card or Licence MUST be shown when signing on at the start.
4. Method of deciding ties: - most cleans, if still tied – most 1s, most 2s, etc.
5. Sections will be closed by a backmarker. Time will be advised at riders briefing, along with any final instructions.
6. All riders on combustion engine machines must have a cut out device connected to the rider by a lanyard, max length 1 metre, so as to stop the engine should the rider and machine be parted.
7. Riders NOT competing in the Championship, can choose to ride as a Clubman on either Route A or B
8. Helmet Cameras are not permitted. Cameras attached to the machine are allowed, by permission from the Clerk of the Course.
9. Parents or Guardians of youth(s) signed on must NOT leave the ground.
10. Protests must be received in writing within 5 days of publication of results accompanied by a £100.00 protest fee.
11. Riders must keep to the flagged route.
12. CLOSING DATE: FRIDAY 29th March 2019
13. IN ORDER TO ACCRUE POINTS IN THE CLASSIC CHAMPIONSHIP A RIDER MUST PRE-ENTER EACH ROUND OF THE CHAMPIONSHIPS. (See SACU classic trials regulations, page 12 paragraph 5)
